

Flip Windshield: for Can-Am Maverick Trail








- When assembling, do not tighten hardware completely.

Windshield Cleaning:


- Do not use window cleaning fluids (Windex, 409, etc) or any solvents (gasoline, denatured alcohol, acetone, etc).
- Never use abrasive cleaners, abrasive pads, or gritty cloths.
- Do not use a windshield wiper blade or install a motorized windshield wiper
- Never use razor blades, scrapers, squeegees, brushes, etc.
- 1. Thouroughly rinse Windshield to float off dirt and mud.
- 2. Using a soft cloth, or microfiber cloth, clean Windshield with warm water and a gentle detergent. Baby shampoo or hand washing soap are recommended.
- 3. To prevent water spots, use a chamois to blot Windshield dry.



- Install Catch and Catch Support to Lower; hardware included with Catch.




- Install Upper to Roll Cage and secure with Clamps and hardware shown.

- Open Upper to just under 90° and secure Clamp to Roll Cage.




- Install Handle and Support to Upper; hardware included with Handle.



Close Upper Windshield and engage Latch.Align Windshield assembly to machine.

- Tighten all hardware completely.

- Install Seal into channel on Roll Cage. Repeat for opposite side.
