



Do not tighten hardware completely unless noted.


Pre-Tapping holes may ease installation even though Self Tapping Bolts are included in kit.



- 1. Install Mounting Bracket (C) to Frame with 5/16"-18 x 1" Lg. Self Tapping Screws.
- Mounting location under machine around front of Seat. See Figs. 1 - 1a.
- Install rear of Nerf Bar (A) to Frame with 5/16"-18 x 1" Lg. Self Tapping screws.
- Mounting location under machine around rear of Seat. See Figs. 2 - 2a.
- 3. Install Nerf Bar (A) to Mounting Bracket (C) with M8-1.25 x 20mm Lg. HHCS, M8 Flat Washers, and M8-1.25 Nylock Nuts. See Figs. 3 3a.
- 4. Repeat steps for opposite side, align to machine, and tighten hardware completely.
