





- Before installing, ensure that all Gaskets in electrical connections are properly seated.
- If Gaskets are not seated use a Flathead Screwdriver to seat.









Removal: Keep all components removed from machine.


Raise front of machine, secure with jack stands, and remove Wheels.








Installation: Do not tighten hardware completely unless noted.






- From outside of machine, insert Lower Shaft (C) up through Firewall and secure to Rack and Pinion with provided hardware.








- Install Motor Mount/Motor assembly onto Lower Shaft (C):
 - Secure Lower Shaft (C) to Motor (G) with provided hardware.
 - Secure Support (F) to Pedal Mount Studs with stock Nuts.




- Insert Upper Shaft (B) into Tilt Steering Assembly:
 - Secure Upper Shaft (B) to Motor (G) with provided hardware.
 - Reinstall Tilt Steering Assembly with stock hardware.
- Reinstall Steering Wheel.








- Install ECU Mount (D) and ECU (H) to Steering Frame with hardware shown.
- Plug in Wiring Harness (J) and make connections. See Wiring Details, page 10.
- Tighten all hardware completely and reverse applicable steps taken during "Removal".
- Install stock Cover will to Motor Mount (A) with stock hardware.









Plug	Function
